Pursuant to the SP Agreement entered by the Company, Beijing Yutai, the Target and the Vendors on 14 August 2015 and the Supplemental Agreement entered by the Vendors, the Company and Beijing Yutai on 26 April 2016, the parties agreed that, as part of the consideration for the acquisition of 49% equity interest in the Target, the Listco Consideration shall be settled by a combination of cash in the amount of RMB18,725,500 and the issue and allotment of 8,396,000 Initial Consideration Shares (subject to adjustment) by the Company to the Vendors, equivalent to a value of RMB 12,500,000, at the issue price of approximately HK\$1.80 per Initial Consideration Share. On 12 May 2016, the Vendors, the Company and Beijing Yutai entered into the 3rd Supplemental Agreement, pursuant to which the parties agreed that under the adjustment mechanism specified in the SP Agreement and the Supplemental Agreement, in the event that the Actual Profit exceeds Amount A, Additional Consideration Shares of not more than 38,440,000 Shares shall be issued to the Vendors. In the event that the Actual Profit exceeds Amount A, the Consideration shall be adjusted upwards and the Company shall settle the Further Consideration, capped at RMB 9,000,000, by the issue of Additional Consideration Shares of not more than 14,280,000 Shares to the Vendor.
