Inspur Group is a leading cloud computing and big data service provider in China and one of China’s large-scale IT enterprise with comprehensive strength. Its business covers four major industrial groups (cloud data center, cloud service and big data, smart city and smart enterprise), providing IT products and services for over 100 countries and regions around the world. Inspur Group is interested in certain listed companies including Inspur Electronic Information Industry Co., Ltd.* (浪潮電子信息產業股份有限公司) (stock code: 000977.SZ) and Inspur Software Co., Ltd.* (浪潮軟件股份有限公司) (stock code: 600756.SH).

The Group is a leading comprehensive one-stop video technology group in China, mainly providing services such as one-stop video application solutions, sales of self-developed products, and full-chain services including video content collection, production, transmission and distribution and terminal broadcasting, to the broadcasters, new media agencies, government agencies, and industrial customers, etc.
